Amelita Mirolo Barn



The City of Upper Arlington was making plans to develop the new Sunny 95 Park that would eventually include an all-season indoor facility. The Upper Arlington Historical Society brought to the City's attention the opportunity to preserve one of the community's oldest farm structures – the Thomas Legg barn, built in about 1838, originally located near the intersection of Fishinger and Reed Roads and later relocated to Lane Road.

Early in 2008, with help from the Friends of Ohio Barns, the barn was

dismantled, tagged and put in storage while options for its preservation and reuse were being explored.

Recognizing the opportunity to combine a historically significant building with a public recreational structure, the Upper Arlington Community Foundation decided to embrace this endeavor as its signature fundraising effort.

Since the Foundation's Preserving UA's Legacy Campaign was launched in the fall of 2009, fundraising has truly been a

community-wide effort, with over 300 residents giving gifts ranging from a \$10 gift to the \$150,000 naming rights from the Mirolo Charitable Foundation. The Foundation has raised more than \$900,000 in pledges and in-kind donations, and continues to accept donations.

From September 16-26, 2010, with the expertise of the Timbers Framers Guild and over 25 of their volunteers as well as members of the Friends of Ohio Barns, a timber frame was built and the Legg barn restored. More than five hundred community residents were in attendance on Sunday, September 26 when the historic Legg barn was hand-raised, merging old with the new into the Amelita Mirolo Barn. This was the first project undertaken by the Timber Framers Guild attaching a historical structure to a new structure.

On May 21, 2011, the Upper Arlington Community Foundation gifted the Amelita Mirolo Barn to the City of Upper Arlington. It serves as one of the community's public gems. Through the generosity and creativity of Upper Arlington citizens and businesses, we have built this beautiful structure for generations to enjoy.



How to reserve space at the barn

The Amelita Mirolo Barn, 4395 Carriage Hill Lane is located in Sunny 95 Park. It is open for rental events year-round Monday through Sunday, 5 a.m. – 11 p.m. It seats 150 with additional capacity on an outdoor patio and stage area. The 3,700 square feet of space is climate controlled and ADA accessible. To schedule an event, please contact the Upper Arlington Parks and Recreation Department at 614.583.5330.

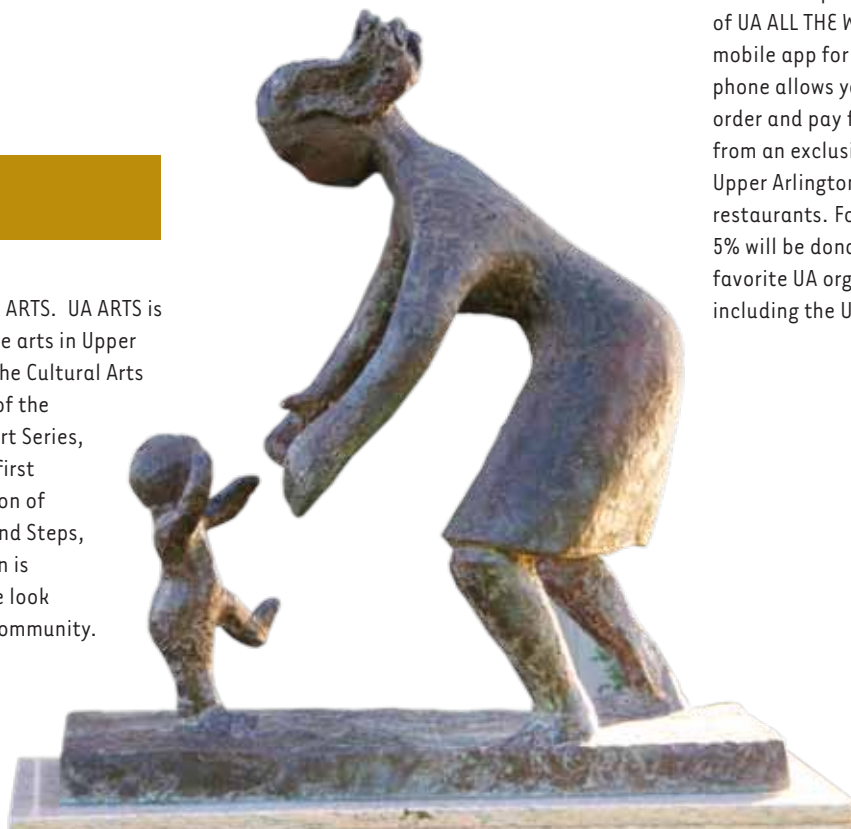


UA All the Way

UACF awards grants semi-annually based on a calendar year; grant requests are due on May 1 and on November 1. UACF intends for our grant application and review process to encourage ideas and proposals from organizations representing a wide variety of fields. The grants committee, comprised of Board members of UACF, reviews the applications and makes recommendations to the full Board of UACF. The Board approves and awards the grants.

UACF has identified the following fields of interest for grantmaking: social services; health and wellness services; environment and conservation; the arts; senior services; community beautification; and community recreation. The following is a list of recent grants:

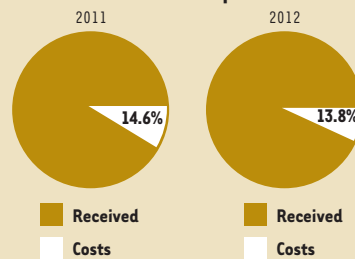
